DENTAL ADVANTAGE MEMBERSHIP

Dental Advantage Membership (DAM) is a reduced-fee, in-house membership plan for families and individuals that allows members to receive quality dental services at reduced prices. Unlike conventional insurance plans, with DA there are **no deductibles, no yearly maximums, and no waiting periods to begin treatment**. Membership benefits begins immediately upon plan registration.

Please be advised, registration is predicated upon having no outstanding account balance and no dental coverage ONLY.

We are introducing this plan for those without dental insurance to ensure access and affordability. This is an annual reduced fee dental plan that allows individuals and families to receive quality dental care from the providers of this office, for a percentage of the office's standard fees. Dental insurance is increasingly confusing, unpredictable, and restrictive not only for you as the consumer, but for us as the provider. This is not an insurance plan, no claims are filed, and no payments are made to any other healthcare providers. We are not a licensed insurer, health maintenance organization or other underwriter for health services. This plan may not be combined with any other offers, discounts, insurance, or advertisements.

MEMBER BENEFITS

- 2 Routine Dental Cleanings per year (Fluoride covered for 18 yrs and younger)
- Any 2 exams per year
- Any and all necessary x-rays
- A 15% savings on additional dental procedures
- A 15% savings on all Implant related services
- A 5% savings on all Orthodontic Services (Invisalign and retainers)

Please note Membership fee is NON-REFUNDABLE.

All members' fees are due and payable at the time of registration and are non-refundable. Plan duration is for one year from registration date. All patient portions for services received are due at time of service in order to receive benefits. Deep cleaning (Scaling and Root Planing-SRP) or MOD Perio-Therapy is **NOT** covered under routine cleanings. All members of Dental Advantage family account will have the same anniversary date as the primary member. Interest-free payment plans of 3 months duration is available upon request and approval. We also accept a third party payment plan called Carecredit. A \$50 fee will be charged for late cancellation or a missed dental appointment. Please notify our office at least **48 business hours** in advance if you must change a scheduled appointment.



DENTAL LIMITATIONS AND EXCLUSIONS

- Demonstrated non-compliance with patient's recommended course of treatment
- The 2 routine cleaning benefit is not to be applied for any SRP (Deep Cleaning) or Periodontal Therapy Treatment modules, it is only for Prophies or Perio-Maintenance.
- Restoration, splints or other appliances used to increase vertical dimension or restore occlusion
- Oral surgery requiring the setting of fractures or dislocations
- Treatment of malignancies, cysts or neoplasms
- Congenital malformations, except congenital anomaly of a tooth or teeth covered from birth
- Hospital benefits for any dental procedure
- Experimental procedures
- Services for injuries or conditions which are covered under Worker's Compensation or Employer's Liability laws
- Services which are provided without cost to the member by any municipality, county or other political subdivision
- Saliva DNA Test
- General anesthesia, Nitrous, Oral Sedation
- Medication/supplies sold at the office. (e.g Whitening Gels, Rx Fluoride Toothpaste, Chlorhexidine etc.)
- Services that cannot be performed because of the general health, physical or psychological limitations of the patient
- Periodontics, endodontics, oral surgery or pedodontics requiring the services of a non-participating dentist. Dr. Kim and Associates are DA participating dentists. Any health care provider outside our office to which you may be referred, are not participants of membership
- Diagnosis and treatment of myofascial pain dysfunction syndrome
- Procedures performed in the hospital
- DA Participants cannot use other dental coverage in conjunction
- Yearly benefits are not carried over to the next year once the membership anniversary date is reached
- Any health care provider outside our office to which you may be referred.
- Benefits cannot be used in conjunction with other discounts.
- Benefits are not transferrable
- Payment plans will be processed with at least 50% paid down and the rest divided into either 3 or 6 months payment plan depending on treatment.
- Membership may not be used in conjunction with promotions

ORTHODONTIC LIMITATIONS AND EXCLUSIONS

- Treatment programs which began before becoming a DA Member.
- Lost or broken appliances.
- Additional fees may be charged by the dentist for
 - a) Gross and consistent noncooperation and/or treatment non-compliance by the patient
 - b) Accidents occurring during the treatment
 - c) Treatment plans involving surgical orthodontics
 - d) Myofunctional therapy
 - e) Temporomandibular joint treatment
 - f) Loose, broken or lost bands/brackets.
